

DIISHA: Future of Healthcare

DIISHA stands for Digital Innovations & Interventions for Sustainable Healthtech Action. This Pilot Project aims to drive digital health adoption despite existing challenges. It leverages digital innovations for various health system needs, benefiting the public, patients, and healthcare personnel. Our initiative necessitates advanced digital technologies for enhancing maternal healthcare, managing infectious diseases, chronic conditions, non-communicable diseases, and health system integration in low-resource settings.

In response to COVID-19, recognizing growing health concerns, DIISHA focuses on upskilling frontline health workers like ASHA workers. This empowers them with digital training, easy medical data recording, and online tools like tablets and smartphones, streamlining patient care. Currently, manual forms can be replaced with real-time digital data, ensuring accuracy. Our health care service target is to screen 125 crore people across India and ensure that medical facilities are made available in rural areas.

INTENT

India witnesses a significant number of newborn fatalities and maternal deaths annually. Patient care in remote areas is often handled by Auxiliary Nursing Midwives (ANMs) and Accredited Social Health Activists (ASHAs). Presently, around 9,00,000 ASHA workers in the country play a pivotal role in disease detection. Recognizing our country's data, we are going to take DIISHA ahead.

DIISHA aims to showcase the practicality of utilizing cutting-edge technologies in healthcare, in line with the Prime Minister's vision. It empowers ASHAs by integrating technology, enabling reliable health data collection to fulfill India's SDG3 objectives. This data will enhance healthcare services for rural communities and leverage DST healthcare provisions.

EXTENT

DIISHA will play a key role in achieving the government mission of conducting universal screenings, eliminating sickle cell anemia by 2030, and establishing Atma Nirbhar Bharat in healthcare by upgrading and modernizing ASHA workers. DIISHA will help India achieve the vision of improving universal health by launching the pilot in 9 different states.

9 PILOT STATES

-Currently Under Consultation of National Rollout



DIISHA, one of Asia's largest Pilot Projects, is now set to enter its piloting phase. These states are the ones that have joined consultation for the national rollout of testing and screening of the beneficiaries. All 29 states have been reached out to and 9 pilot states have been shortlisted for the pilot. In total there are 72 districts that will be covered under DIISHA.

Digital Health Annuity Model (DHAM)



- Out of the 100% health budget of the state, 30% portion is estimated to be redirected to DISHA in only those specific districts where the pilot is being conducted. This portion is redirected against the budget of those diseases only, which are already being covered by DISHA in its NCD list for healthcare service delivery.
- DIISHA is aimed to achieve a higher degree of precision, transparency and accountability of healthcare service delivery with the use of advanced technologies. Despite all indicators of higher efficacy in terms of implementation, penetration, and coverage, DIISHA is projected to be spending 10% lesser budget from its first day.
- As per the Ministry of Commerce and Invest India report, 100% FDI is allowed in healthcare projects and joint initiatives. As of now, 20% share or investment out of this 100% is open for private investors in DISHA's DHAM Public Private Partnership Model.
- An annuity is an annual income from infrastructure which takes typically a period of 12 to 24 months in physical infrastructure projects to contribute to the Operational Expenditure (OpEx.). DIISHA being pilot project of the first 'physical data center infrastructure' of health-care utilizes state and centre combined support to patch this period with a 20% estimated annuity for a limited tenure.
- 20% of DISHA's total spending budget is aimed to be earned via operational services along with validation and testing support extended to government entities, 'regulatory and certification bodies', and 'population health management institutions' and entities of healthcare.







WHAT IS ONE HEALTH

One Health is an integrating idea that brings different sectors together to solve the health, productivity, and conservation challenges and has major implications for indic with its diverse wildlife, one of the largest livestock populations and high density of human population, carries heightened risks for inter-compartmental spread of diseases. Covid pandemic, recent authorisks of Lumpy likin Disease in cattle and the constant threat of Avian influence show that it is not just about addressing diseases from human health point of view (zoonasis) but we need to address the livestock and wildlife aspects. This also opens apportunities for leveraging the complementarity and strengths that is inherent in each sector and devise integrated, robust and agile response systems.
